Dear Mr. DeLawyer:

In accordance with Section 905.40 of the 2003 Private Sewage Disposal Licensing Act and Code, and based upon review of the plans submitted to this office, the Illinois Department of Public Health hereby issues approval for the following Fralo model septic tank:

ST-750 – 750 gallon, two compartment, one piece tank
ST-1060 – 1060 gallon, two compartment, one piece tank
ST-1250 – 1250 gallon, two compartment, one piece tank
ST-1500 – 1500 gallon, two compartment, one piece tank

Septic tanks manufactured by Fralo Plastech, are subject to the following conditions:

1. The septic tank approval number **#152** with the prefix "ILL" and the internal liquid capacity (number of gallons) shall be placed on the tank above, or next to, the outlet pipe so that this information is readily visible after installation and prior to covering.
2. There shall be no deviations from the plans and specifications submitted for approval unless revised and specifications therefor shall first have been submitted to the Illinois Department of Public Health and a supplemental approval issued therefor.
3. The Illinois Department of Public Health, in issuing this approval, has relied upon statement representations made by the applicant in the application therefor; and in case any statement or representation in said application is found to be incorrect, this, thereupon, waives all further rights thereunder.

4. This approval does not relieve the applicant or his authorized representative from securing or complying with any municipal or county zoning or other ordinances applicable thereto.
5. Approval of this unit by the Illinois Department of Public Health is limited to design and is in no way intended to guarantee the proper function of the unit.
6. The Illinois Department of Public Health approval number shall not be used on any other tank other than the septic tank for which it has been issued.
7. Fralo Plastech shall be responsible for maintaining a record of all septic tanks sold in Illinois as described in the Private Sewage Disposal Code, Section 905.40 a) 3).
